## ATM Hooah Tent Tenant Electrical Devices

To meet any electrical needs and provide adequate power to your Hooah Tent, please list the electrical devices that will be present in the tent on race day, (this includes devices provided by caterers or third parties) This enables:

- 1) ATM to configure generators to supply an adequate power source for the present electrical devices.
- 2) ATM to provide adequate power outlets for the present electrical devices.

<sup>1</sup>Daisy chaining of power cords or power strips is prohibited. Each tent comes with two 20 amp quad boxes (total of eight outlets) and additional quad boxes are available for rent. Please be transparent in the assessment of electrical needs. If daisy chaining is observed, the offending power cords or power strips may be removed and the tent will lose the use of electrical devices.

### ATM Hooah Tent Rules and Restrictions

The following rules and restrictions are strictly enforced in the Hooah Tent Zone (HTZ):

#### **PROHIBITED ITEMS:**

- Open flames, propane tanks, grills, and sterno canisters
- Daisy Chaining<sup>1</sup> of power cords and power strips
- Space Heaters and personal generators
- Inflatables (due to flight paths over the Pentagon)
- Alcoholic beverages and any materials promoting alcoholic beverages
- Sampling, promoting or displaying commercial sponsor products/services, other than official ATM sponsors products/services
- Stakes or any other objects hammered into the Pentagon parking lot
- Playing or broadcasting music or engaging in any other entertainment in the HTZ before 8am on race day.

#### **RULES:**

- 1. Funding Commands, Garrisons, Installations and Units
  - Funding for Hooah tents should be coordinated with your Command fiscal and/or MWR sports director office. See 27 Apr 15 IMCOM Memorandum re ATM Funding.
- 2. Hooah Tent supporters conflicting with 2020 ATM Official Sponsors and Partners are not permitted.
  - View the list of official ATM Sponsors and Partners at www.armytenmiler.com/about-atm/sponsors
  - Hooah Tent supporters must be approved by ATM staff.
  - Banners of Hooah Tent Supporters are permitted inside Hooah Tents Only. Displays of any form of advertising placed outside of the Hooah Tent will be removed.
- 3. Tent displays and activities may only extend up to 4' beyond the tent.
- 4. Command, Installation, Garrison or Organization banners may be displayed **outside** the Hooah tent provided they meet the following guidelines:
  - Banners must not be larger than 3' high x 20' wide, have wind slits and not extend beyond 4' from the tent.
  - Use of adhesive materials on tents is prohibited. Plastic zip ties are authorized to affix banners (or other display materials) to existing tent frame.
  - Any banner containing a Hooah tent supporter's name must be limited to recognizing the supporter, e.g., "[Garrison/Command/Installation/Org Name] Supported by [Supporter's Name/logo];" or, "[Supporter's Name/logo] serving [Garrison/Command/Installation/Org Name]," or words to that effect.
